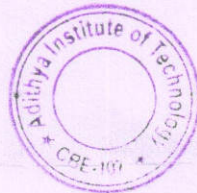
The Indemnity Bond and the other supporting documents submitted in respect of the above College have been accepted by the University Grants Commission.




